## MISSION TIKI DRIVE-IN AND SWAP MEET

## **RULES TO OBSERVE DURING COVID19 PANDEMIC**

Pursuant to Guidance from the State of California and by order of the City of Montclair, Emergency Order No. 05-21-20-1 establishes the following rules and regulations for use of the Mission Tiki Drive-In during the COVID19 public health crisis. VIOLATION OF, OR FAILURE TO COMPLY WITH, THIS ORDER IS PUNISHABLE BY FINE, IMPRISONMENT, OR

BOTH. (§148 and §409 of the California Penal Code; §120295 of the California Health and Safety Code; and Chapter 1.04, et seq., Chapter 1.12, et seq. and § 6.08.100.B of Chapter 6.08 of the Montclair Municipal Code).

- **A.** Concession stand operations. Please observe social distancing at all times. Proper social distancing requires a six-foot separation between persons other than household members. Please observe the floor placards. No more than five customers shall be permitted in the concession stand for each service line, with a maximum of two per household who may stand in line together.
- **B.** Restrooms. Restrooms are sanitized at least once hourly during swap meet events and film screenings, and after each swap meet event and each evening's movie screenings. A maximum of four persons shall be permitted in each restroom at any one time, if social distancing can be maintained. If social distancing cannot be maintained, a maximum of two persons shall be permitted in each restroom at any one time.
- **c.** Drive-In Vehicle Parking. Please park your vehicle in compliance with the below illustrative plan
  - on the horizontal plane, vehicles are separated by approximately 6 feet to observe proper social distancing:

**D.** Vendor Booths. Please set your booth in compliance with the below illustrative plan — on the horizontal plane, booths are separated by approximately 12 feet to observe proper social distancing:

Vendor booths are to be positioned to face the drive aisle adjacent to the vendor space.

- **E.** To the extent practical, swap meet vendors shall display their wares and merchandise for sale in a manner that provides for easy and accessible viewing by potential customers, and limits product handling by customers.
- **F.** Except when interacting with employees of the Mission Tiki Drive-In, persons inside vehicles, even with windows down, are not required to wear face coverings; however, persons outside of vehicles are required to wear face coverings at all times, including persons going to restrooms and persons going to the concession stand for pickup of food and/or drink items.
- **G.** Employees, vendors and customers shall wear face coverings at all times when on the property and outside of vehicles, including when in the concession stand, restrooms, and at swap meet vendor spaces.
- H. Upon entry to the property, ownership/management shall do temperature screening on each person in a vendor's party. Each customer shall be asked at the point of entry to the property if he/she, and any minor under their custody, has any signs of illness before entry is permitted. Any vendor or person in a vendor's party, and any customer, or person in a customer's party, exhibiting or acknowledging any sign(s) of illness shall be denied entry.
- I. Employees, vendors and customers shall wear face coverings at all times when on the property and outside of vehicles, including when in the concession stand, restrooms, and at swap meet vendor spaces.
- J. The setting up of lawn chairs, portable chairs, blankets, or seats outside of a vehicle is permitted for swap meet vendors for their personal use (not customer use), but is strictly prohibited during and for film screenings.
- **K.** Persons from the same vehicle may sit in the back bed of a truck or the rear cargo area of a van, SUV, or other similar vehicle for viewing screened films; provided, however, that no person shall exit such areas without wearing a face covering.
- L. For and during film screenings, the gathering of persons not from the same vehicle is prohibited.
- **M.** Drinking of alcoholic beverages is prohibited.
- **N.** Smoking of cannabis is prohibited.
